We take the security business very seriously so please read carefully and fill out the application completely.

IMPORTANT: FBI background checks are required and performed by licensing agencies. Applicants will <u>NOT</u> qualify for an AZDPS security guard license if you are under 18 years of age, **convicted of ANY FELONY**, or have ever been convicted of any **Misdemeanor** involving:

- Fraud
- Domestic or Physical Violence
- Assault or Endangerment
- Sexual Misconduct
- Rape or Sexual Abuse
- Illegal Use or Possession of a Deadly Weapon
- Any Theft or Drugs within the Last 5 Years
- On Probation or Parole or have any Outstanding Warrants
- For further information involving a list of disqualifiers, go to the AZDPS website listed on the attached form.

*Note: it is a felony to file a false application to obtain a Security Guard License punishable by 18 months in prison and \$150,000 fine.

Mitchells supplies 2 uniform shirts. Employees must wear <u>black</u> pants, <u>black</u> shoes, <u>black</u> socks, and <u>black</u> belts, and a duty belt, per uniform specification. We will cover this and more upon your employment acceptance.

<u>This job entails' mostly nights and weekend shifts, all holidays, as well as on call day shifts</u>. We work primarily when other businesses are not open. <u>Mitchell's job requirements for every</u> employee include:

- Access to the internet, email address, for employee schedules
- A valid Driver's License
- Your own running, reliable Vehicle capable of charging radios
- An active cell phone that you can be reached at 24 hours a day
